

## **Registrant/Player Waiver and Release of Liability**

This waiver and release of liability (the "Agreement") by the participant (the "Participant"), in favor of Netcare Corporation and Maryhaven Inc., its directors, officers, volunteers, sponsors, agents, and any affiliated entities (collectively referred to as the "Released Parties").

### **1. Assumption of Risk**

The Participant acknowledges and agrees that participation in the Smash the Stigma Pickleball Tournament (the "Event") involves physical activity and the inherent risk of injury, including but not limited to slips, falls, collisions, or other incidents that may result in bodily harm, property damage, or other loss. The Participant voluntarily assumes all such risks associated with participation in the Event.

### **2. Release and Waiver**

The Participant hereby releases, waives, and discharges the Released Parties from any and all liability, claims, demands, or causes of action, whether known or unknown, arising out of or related to any loss, injury, or damage sustained by the Participant as a result of participation in the Event, including any negligence by the Released Parties.

### **3. Indemnification**

The Participant agrees to indemnify and hold harmless the Released Parties from any and all claims, demands, liabilities, costs, or expenses, including attorneys' fees, arising out of or related to the Participant's participation in the Event.

### **4. Medical Treatment**

The Participant consents to receive medical treatment deemed necessary in the event of injury, accident, or illness during the Event. The Participant releases and discharges the Released Parties from any claims or liability related to such treatment.

### **5. Compliance with Rules**

The Participant agrees to comply with all Event rules and regulations as provided by the Event organizers. The Participant acknowledges that failure to adhere to these rules may result in removal from the Event without refund.

### **6. Photography and Media Release**

The Participant grants permission to the Released Parties to use photographs, videos, or other media of the Participant taken during the Event for promotional purposes, without compensation or prior approval.

## 7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of Ohio, without regard to its conflict of laws provisions.

## 8. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

## 9. Entire Agreement

This Agreement constitutes the entire understanding between the Participant and the Released Parties with respect to the subject matter hereof and supersedes all prior negotiations, agreements, and understandings.
